In his role he provides leadership to a team of congressional liaisons and supports Department of the Air Force senior leaders to facilitate successful Congressional engagements with the Appropriations and Budget Committees in advocacy of the President's Budget request.

Mr. Osborne entered government service in 2003 as a Cost Analyst within the Air Force Palace Acquire Intern Program. Throughout his career he has taken on roles of increasing responsibility within the financial management community at both the installation and Command level as well as serving in the first cadre of financial analysts during the stand-up of the FM Center of Expertise.
