CMSgt Kaci K. Duhart is the Executive for Enlisted Matters to the Assistant Secretary of the Air Force for Financial Management and Comptroller. He serves as the principal advisor to the Assistant Secretary on the utilization, training and assignment of over 2,000 financial management enlisted personnel throughout the Air Force. As the Air Force Career Field Manager for financial management personnel, he is the Headquarters Air Force focal point for all financial management functional, training, contingency, manpower and personnel issues. He also serves as the secretariat's ambassador to the financial management enlisted force, disseminating career field information and addressing concerns.

CMSgt Duhart was raised as an Air Force dependent and entered the United States Air Force in 1992 after graduating from Ramstein American High School. His diverse background includes various duties in financial management, financial services, quality assurance, and contingency skills training across multiple Major Commands and service components. In addition to working in joint service and special operations environments, he has had the opportunity to serve as a four-time Comptroller Squadron and Wing Staff Agencies Senior Enlisted Leader. CMSgt Duhart has deployed in direct support of Operations SOUTHERN WATCH, IRAQI FREEDOM, and NEW DAWN.
