Honorable Kristyn E. Jones is the Assistant Secretary of the Air Force for Financial Management & Comptroller. As the Department of the Air Force's comptroller and chief financial officer, she serves as the principal adviser to the Secretary, Chief of Staff of the Air Force and Chief of Space Operations on all financial matters. She is responsible for providing financial management and analytical services necessary for the effective and efficient use of Air Force resources, to include nearly 700,000 military and civilian personnel and a budget of over \$194 billion. This includes directing the development of the Air Force program and budget, overseeing the Air Force Cost Analysis Agency's acquisition and operational cost analysis, providing analytical services necessary for the effective and efficient use of Air Force resources and conducting Air Force accounting and finance operations.

Prior to her current position, Hon Jones was a Managing Director in KPMG's Federal Advisory practice, where she supported the Department of Defense, Veterans Affairs, and other Federal clients. Previously, Hon Jones served in a variety of government positions. She entered the Senior Executive Service in June 2008 serving as Director and then Deputy Assistant Secretary of the Army for Financial Information Management until 2014. From 2007 to 2008,



Hon Jones was assigned as the Special Assistant to the Assistant Secretary of the Army (Financial Management & Comptroller) for Cost Management Transformation. Prior to this role, Hon Jones was the Director of Enterprise Transition Planning at the DoD Business Transformation Agency (BTA) and served as a Financial Manager at the Office of Naval Research. Earlier in her career, Hon Jones held management positions at two Fortune Five Hundred companies, Capital One and Advanced Micro Devices. Hon Jones also served as a Military Intelligence Officer in the U.S. Army, where she held a variety of leadership positions.
