<u>Description of Services Financed:</u> Service support contracts include multiple areas throughout the Air Force such as Headquarters Staff Augmentation, Advisory and Assistance Services, Federally Funded Research and Development Centers, and other Knowledge Based Services

Reporting Limitations: Currently the Air Force does not have a system in place to track the actual number of contractor full-time equivalents that are supporting the Service. The contractor employs their staff to perform a service. The number of full-time equivalents employed by the contractor can vary depending on the service being provided. The number of contractor full-time equivalents reported is formula based. The Air Force is currently working on a system which will track contractor full-time equivalents.

<u>Summary of Increases/Decreases</u>: The increases from FY 2019 to FY 2020 are primarily due to an increase in weapon system sustainment and facility maintanence contract costs. These increases directly support the Air Force's lethality by ensuring weapon systems are mission ready and our facilities are sustained and modernized to keep up with the mission demands while we fight from home.
